Medical Imaging Systems Ltd is committed to reducing our emissions by 2050.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

This is the first year Medical Imaging Systems are reporting our baseline emissions.

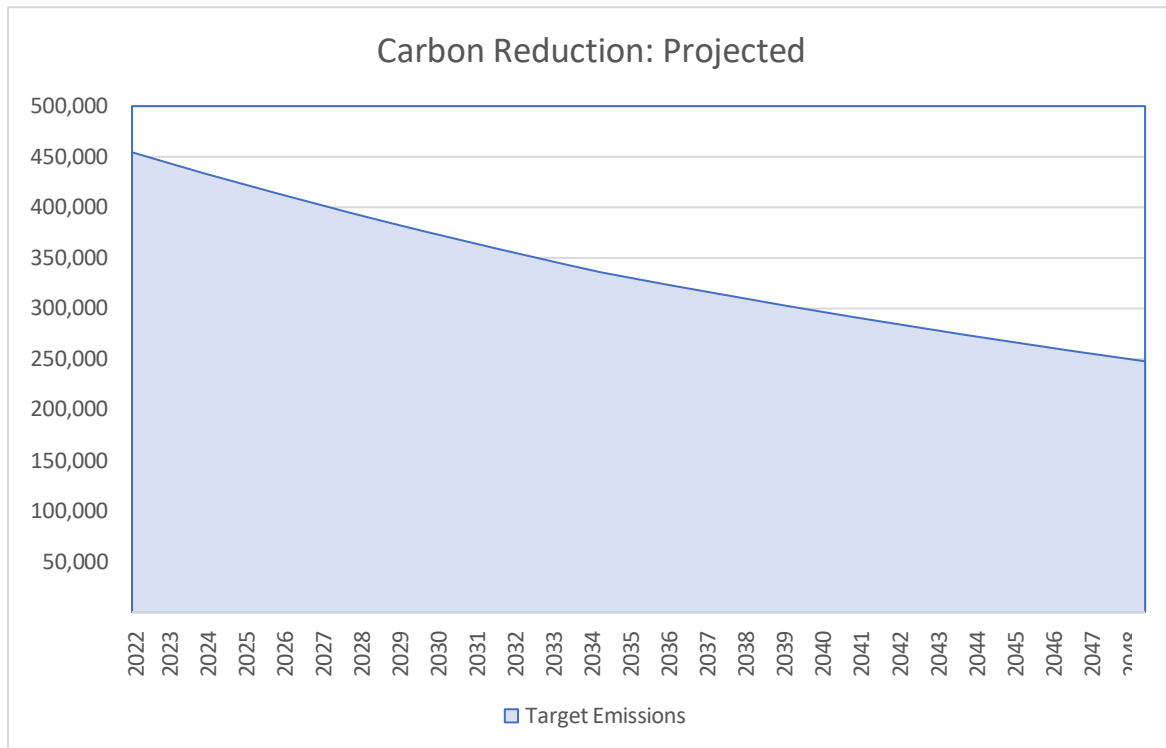

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next thirteen years to 335,610 tCO₂e by 2035. This is a reduction of 30%

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. The carbon emission reduction achieved by these schemes equate to 335,610 tCO₂e, a 30%ge reduction against the 2022 baseline and the measures will be in effect when performing the contract

Medical Imaging Systems Ltd already have certification with ISO14001, we are currently looking into changing our fleet vehicles to more electric vehicles, and already looking at making all of our waste 100% recyclable

In the future we hope to implement further measures such as:

Changing the full fleet to electrical vehicles, reducing our waste, using more energy efficient appliances, reducing business travel, engaging with our suppliers on more efficient delivery and packaging methods.
